# **Code of Conduct Proposal**

Maggie has emailed the board with a proposed Code of Conduct document and a Policy for Addressing Violations document for discussion at this board meeting. Maggie opens up discussion of the documents so board members can offer their thoughts. Board thoughts:

- The information in the proposed code of conduct is currently covered in the organization's bylaws.
- To alter the bylaws takes a vote of the membership
- Code of Conduct could possibly prohibit the board from acquiring/recruiting new board members
- Personal respect and respect should rule on the board-Conduct should be appropriate for all members of the board
- Code of Conduct would change the board from informal to formal and add another layer of complexity.

Maggie feels that it is unacceptable to be personally attacked by another board member while conducting board business and that it needs to be formally addressed and cannot be ignored. Board suggestions in lieu of adopting the Code of Conduct:

- A letter that anyone can sign that states any further behavior will designate removal from the board.
- Sanction or removal of the offending board member(s)
- The offended board member brings up the situation before the board for discussion at a regularly scheduled board meeting and the board decides what action will be taken.
- All parties should be in attendance at the board meeting in order for a discussion to take place

Board discussion around the theme of roles/access of the website and the social media accounts. Board feels that all of these accounts should have multiple board members with

access to the sites. Board members feel that it is difficult to discuss the access to the sites without the webmaster in attendance. There are questions about each board member's permissions and how the webpage is set up that cannot be answered in this meeting.

#### Webmaster directive:

Motion from Donna: We want access restored as quickly as possible and we want a response as to why it is either done or why it can't be done within one week and that the president and vice president granted full access to the website.
